**Community in Crisis:** Far Hills Race Meeting funding will help fund recovery support programs and services at Community in Crisis' (CIC) Community Hub, located in the center of Bernardsville. CIC helps recovering addicts live a healthy and substance-free lifestyle, providing support services such as recovery yoga, acoustic coffeehouse evenings, cooking classes and volunteer opportunities, among others.



**Cancer Support Community:** With funding from the Robert Wood Johnson University Hospital Somerset-Far Hills Race Community Partnership, Cancer Support Community Central New Jersey (CSCCNJ) will focus on greater multicultural outreach, providing educational and culturally appropriate programs to cancer patients and their families (with a special emphasis on children) who come from traditionally underserved communities.



**Bonnie Brae:** With funding from Far Hills Race Meeting, Bonnie Brae will support its new Family Resource Center, which serves families affiliated with the organization and those from the surrounding community. The partnership will also support integrated health and wellness training and education in the larger community.



**LifeCamp:** LifeCamp—a summer camp serving children from underprivileged communities—will use funding from Far Hills Race Meeting to fund the LifeCamp Infirmary and its aquatics program, which is used by 300 children for 90 minutes per day. Many inner-city children suffer high rates of childhood obesity, and swimming is an ideal activity for both recreation and exercise.
