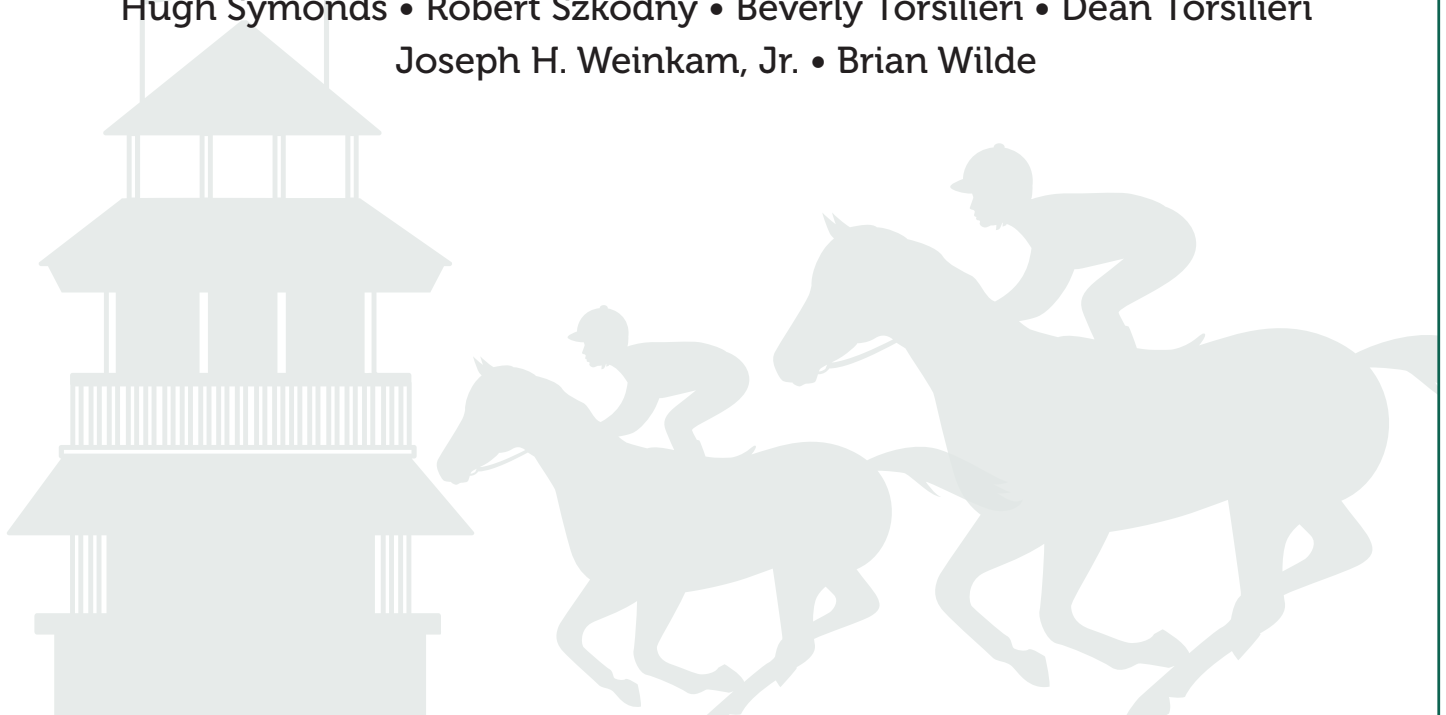

IN MEMORIAM

This 101st Running of the Far Hills Race Meeting is dedicated in memory of the Races' most predominant figure for over 50 years.

JOHN T. von STADE
1938-2021



John T. von Stade served the Far Hills Race Meeting Association for over 50 years. During his tenure he was instrumental in growing the event from a small local steeplechase day in the country to America's richest day of steeplechasing.

Born June 28, 1938, in Old Westbury, NY John was the youngest of F. Skiddy and Katherine von Stade's eight children. He graduated from St. Paul's School in Concord NH and Harvard University, developing his passion for music and art at both schools. Following his college graduation, von Stade attended the Aspen School of Music and served in the Army Reserves. He then spent time in the banking world before opening the Essex Gallery of Sport in Bedminster, NJ.

Participating in Thoroughbred racing was a natural fit for von Stade. His father was a founder of the National Museum of Racing in 1950, president of the National Steeplechase Association, and the final president of the Saratoga Association, which owned and operated Saratoga Race Course before its assimilation into what is now the New York Racing Association. In his youth, he harrowed the track at Saratoga between races.

Guy Torsilieri, who spent 35 years leading the Far Hills Race with John, said he would do everything from helping bed the horse stalls to managing the volunteers. "He was like an old school guy, but he managed to change with the times," said Mr. Torsilieri, the former president of the National Steeplechase Association. "He had an incredible way about him, so gentle and focused. He knew which way things needed to go and should go." Mr. Torsilieri added that Mr. von Stade was the 'fabric and glue' that held things together between the Races and the Foundation that donates to the Robert Wood Johnson University Hospital in Somerville, New Jersey. The hospital houses the Steeplechase Cancer Center and the von Stade Lobby, built with the more than \$18 million raised by the Far Hills Race proceeds.

In addition to growing the Far Hills Race from a small country steeplechase to a social event with up to 40,000 spectators, John helped navigate the Far Hills Race Meeting Association's most ambitious endeavor of purchasing the 230 acre Moorland Farm. Prior to 1998, Moorland Farm was owned by AT&T and the Far Hills Race Meeting Association only had permission to operate the event on a year to year basis. John's efforts in purchasing the property helped solidify the long term vision for American Steeplechase Racing.

In 2014, John was honored for his 50 years in the leadership of the Far Hills Race Meeting Association. Today, we honor him by dedicating the "Sport of Kings, Maiden Hurdle Stakes Race" in his name.

John is sorely missed as a fixture of the Far Hills Races Meeting Association.
